Alaska LNG Project**

Dear Ms. Bose:

Pursuant to the Federal Energy Regulatory Commission's ("FERC" or "Commission") regulations at 18 C.F.R. § 157.21 (2014), ExxonMobil Alaska LNG LLC, ConocoPhillips Alaska LNG Company, BP Alaska LNG LLC, TransCanada Alaska Midstream LP and the Alaska Gasline Development Corporation (the "Applicants") request approval to commence the Commission's pre-filing procedures for the Alaska LNG Project ("Project"). The Applicants plan to construct one integrated LNG Project with interdependent facilities for the purpose of liquefying supplies of natural gas from Alaska, in particular the Point Thomson Unit and Prudhoe Bay Unit production fields on the Alaska North Slope ("North Slope"), for export in foreign commerce.

Given the extensive scope of the Project, initiating the pre-filing process will (i) enhance the exchange of information with Commission Staff, (ii) assist in the coordination of agency activities, (iii) more efficiently accommodate the time required to complete stakeholder engagement, (iv) support the completion of field activities given the seasonal nature of this work in Alaska and (v) facilitates the receipt of various governmental approvals as required by the Project.

As required by 18 C.F.R. § 157.21(d)(1-12) (2014) of the Commission's regulations, the Applicants provide the following information in support of this request.

***1. A description of the schedule desired for the project including the expected application filing date and the desired date for Commission approval.***

It is anticipated that an application pursuant to Section 3 of the Natural Gas Act ("NGA"), 15 U.S.C. § 717b (2006) will be filed in September 2016, requesting that the Commission issue the authorization for the Project no later than July 2018. Below is a table of key milestone activities and schedule targets:

**2. For LNG terminal facilities, a description of the zoning and availability of the proposed site and marine facility location.**

The NGA (15 U.S.C. § 717a(11) (2006)) and FERC regulations (18 C.F.R. § 153.2(d) (2014)) define “LNG terminal” to include “all natural gas facilities located onshore or in State waters that are used to receive, unload, load, store, transport, gasify, liquefy, or process natural gas that is ... exported to a foreign country from the United States.” With respect to this Project, the “LNG terminal” includes: a liquefaction facility (“Liquefaction Facility”) in south central Alaska; an approximately 800-mile, large diameter gas pipeline (“Mainline”); a gas treatment plant (“GTP”) on the North Slope; a gas transmission line connecting the GTP to the Point Thomson Unit (“PTU”) gas production facility (“PTU Gas Transmission Line”); and a gas transmission line connecting the GTP to the Prudhoe Bay Unit (“PBU”) gas production facility (“PBU Gas Transmission Line”). All of these facilities are essential to export natural gas in foreign commerce. These facilities are further described in Response No. 3 below.

Land access has been acquired for approximately 80% of the Project’s footprint across the Liquefaction Facility, Mainline, GTP, PTU Gas Transmission Line, and PBU Gas Transmission Line to conduct the necessary studies to support the pre-filing process and resulting NGA Section 3 application. Specific to the Liquefaction Facility, over 120 acres of fee land has been acquired, approximately 100 additional acres are under contract for purchase, and additional properties are in the process of being acquired, including nearly 30 acres of Kenai Peninsula Borough land in the Nikiski area. In regards to zoning requirements for the current proposed Project footprint, only the North Slope Borough has formal zoning restrictions for oil and gas facilities at this time. The Applicants believe that the level of access to land acquired is sufficient to enter FERC’s pre-filing process. Additional details about land access and acquisition activities can be found under separate cover in the Application for Long-Term

Authorization to Export Liquefied Natural Gas, filed with the U.S. Department of Energy Office of Fossil Energy (“DOE/FE”) on July 18, 2014 (DOE/FE Docket No. 14-96-LNG).<sup>1</sup>

***3. A detailed description of the project, including location maps and plot plans to scale showing all major plant components that will serve as the initial discussion point for stakeholder review.***

The Project includes a new Liquefaction Facility on the eastern shore of Cook Inlet in the Nikiski area of the Kenai Peninsula. The Liquefaction Facility will include the structures, equipment, underlying access rights and all other associated systems for pre-processing (other than that performed by the GTP) and liquefaction of natural gas, and storage and loading of LNG, including terminal facilities (dock) and auxiliary marine vessels used in support of marine terminal operations (excluding LNG carriers). The Liquefaction Facility includes three (3) liquefaction trains combining to process approximately 20 million metric tons per annum (“MTPA”) of LNG. Three (3) 160,000 cubic meter ( $m^3$ ) tanks will be constructed to store the LNG. The Liquefaction Facility will be capable of accommodating two (2) LNG carriers. The size range of LNG carriers that the Liquefaction Facility will accommodate is to be determined through further engineering study and consultation with the United States Coast Guard (“USCG”) as part of the Waterway Suitability Assessment (“WSA”) process.

Attached hereto as Exhibit A are general maps of the Project footprint, which include the general locations of the Liquefaction Facility and GTP. Detailed plot plans will be developed during the pre-front end engineering and design (“pre-FEED”) process and provided to the Commission when finalized.

In addition to the Liquefaction Facility, the Project includes the following interdependent facilities:

- **Mainline:** A new large-diameter natural gas pipeline approximately 800 miles in length extending from the Liquefaction Facility to the GTP on the North Slope, including the structures, equipment, and all other associated systems. The Mainline will include: compressor stations, heater stations, meter stations and various mainline block valves within the permanent pipeline right-of-way footprint; pig launcher and receiver facilities; and associated ancillary and auxiliary facilities. Ancillary and auxiliary facilities will include additional temporary work spaces, access roads, helipads, construction camps, pipe storage areas, contractor yards, material extraction sites, and material disposal sites. Along the Mainline route, there will be at least five (5) off-take interconnection points to allow for the opportunity for future in-state deliveries pursuant to an agreement with the State of Alaska. The size and location of such interconnection points are unknown at this time. None of the facilities used to move natural gas away from these off-take points will be part of the Project.
- **GTP:** The Project includes a new GTP and associated facilities near the PBU for receiving natural gas from the PBU Gas Transmission Line, the PTU Gas Transmission Line and/or other facilities. The GTP will treat/process the natural gas to meet the feed

gas specifications of the Liquefaction Facility and provide an average annual capacity of 3 – 3.5 billion cubic feet per day (“BCFD”) to the Mainline.<sup>2</sup>

- PBU Gas Transmission Line: The Project includes a new natural gas transmission line extending approximately one mile from the inlet flange of the GTP to the outlet flange of the PBU gas production facility.
  - PTU Gas Transmission Line: The Project includes a new natural gas transmission line extending approximately 60 miles from the inlet flange of the GTP to the outlet flange of the PTU gas production facility.
4. *A list of the relevant federal and state agencies in the project area with permitting requirements. For LNG terminal facilities, the list shall identify the agency designated by the governor of the state in which the project will be located to consult with the Commission regarding state and local safety considerations. The filing shall include a statement indicating:*
- (i) *That those agencies are aware of the prospective applicant's intention to use the pre-filing process (including contact names and telephone numbers);*
  - (ii) *Whether the agencies have agreed to participate in the process;*
  - (iii) *How the applicant has accounted for agency schedules for issuance of federal authorizations; and,*
  - (iv) *When the applicant proposes to file with these agencies for their respective permits or other authorizations.*

Attached hereto as Exhibit B is a preliminary list of the federal and state agencies in the Project area with permitting responsibilities. The Applicants will supplement this list as necessary as the Project is further developed and additional information becomes available. A number of federal and state agencies have been contacted and they have expressed their willingness to participate in the pre-filing process, as documented in Exhibit B. The Applicants note that the Governor of Alaska has not at this time designated an agency for consultation regarding state and local safety considerations with respect to the LNG facilities. The Applicants will engage with this agency if it is designated.

Preliminary agency engagement for the Project commenced in 2013, prior to the 2013 summer field season.<sup>3</sup> The Applicants believe that federal and state environmental permitting requirements can be satisfied concurrently with FERC’s environmental review of the Project.

The Applicants will supplement the preliminary list in Exhibit B with a detailed schedule for each permit or other authorization, as appropriate, required for the Project. The Applicants will continue to work with federal and state agencies to define the appropriate schedule for filing each individual permit application, and anticipate filing for major federal and state authorizations and permits soon after filing the FERC NGA Section 3 application. Major state filings include the state pipeline right-of-way lease process and major source air permitting.

Summer field season work conducted in 2013 and 2014 has included cultural resources surveys, fishery and hydrology studies, wetlands and upland vegetation mapping, and other common types of environmental and technical field data collection.

**5. A list and description of the interest of other persons and organizations who have been contacted about the project (including contact names and telephone numbers).**

Public outreach for the Project was initiated prior to the commencement of the 2013 summer field season and the land acquisition associated with the Liquefaction Facility. The Applicants are conducting similar outreach during the 2014 summer field season. As of July 31, 2014, more than 100 meetings have been held with agencies, individuals, groups and organizations regarding the Project. The Applicants will hold additional meetings in the future. Attached hereto as Exhibit C is a list of the contacts made as of July 31, 2014, including contact names and telephone and/or email information and the type of meeting.

**6. A description of what work has already been done, e.g., contacting stakeholders, agency consultations, project engineering, route planning, environmental and engineering contractor engagement, environmental surveys/studies, and open houses. This description shall also include the identification of the environmental and engineering firms and sub-contractors under contract to develop the project.**

Due to the common footprint and location of certain components of the Project with respect to several prior project proposals to develop North Slope natural gas resources, significant amounts of pre-existing information are available that have common attributes with the baseline studies necessary for the Project and that have been shared with Alaska stakeholders. The Applicants intend to incorporate into this Project's administrative record those portions of the administrative records that exist for the Alaska Pipeline Project ("APP") (FERC Docket No. PF09-11-000) and the Denali – The Alaska Gas Pipeline ("Denali") (FERC Docket No. PF08-26-000) that address similar facilities and the same geographic areas as certain components of the Project (e.g., the Mainline from a point near Livengood, Alaska, to the outlet of the GTP, the GTP, and the PTU Gas Transmission line). The Applicants also intend to incorporate into this Project's administrative record certain portions of the administrative record associated with the October 2012 Environmental Impact Statement ("EIS") developed by the U.S. Army Corps of Engineers, Alaska District, for the Alaska Standalone Pipeline Project ("ASAP")<sup>4</sup> because much of the ASAP's footprint from approximately Willow, Alaska to the North Slope is in close proximity to this Project's footprint. The Applicants will work with Commission Staff to identify the specific portions of the APP, Denali, and ASAP administrative records to be incorporated into this Project's administrative record, in particular the public scoping and environmental and socioeconomic analyses.

**Contacting Stakeholders**

In addition to the responses provided above and in Response Nos. 4 and 5, for the Project components south of Livengood, local and state officials have been contacted about the Project along with landowners along the Mainline route to secure permission for environmental and engineering field surveys.

## Project Engineering

The Project incorporates certain prior work by the Applicants, their respective affiliates and others. Since 2012, the new engineering work conducted includes the following:

- Liquefaction Facility: selected preferred site, initiated a metocean data gathering program, and progressed work on LNG facilities capacity.
- Mainline: progressed early hydraulics and materials design studies.
- GTP: confirmed viability of a three-train design, defined the CO<sub>2</sub> design/handling basis, and progressed work on modular plant design and sealift plans.

## Mainline and Transmission Line Segments Route Planning

The Applicants have established a preliminary study corridor for the Mainline and transmission line segments of the Project. The corridor for each segment will be the basis of preliminary environmental survey, engineering studies, and cost estimates. The routes will be finalized with, among other things, the benefit of stakeholder input during the pre-filing process.

## Environmental Surveys/Studies

A site selection study was conducted that reviewed 22 potential sites in south central Alaska for the Liquefaction Facility. Following this study, the site in the Nikiski area as shown in Exhibit A was selected and environmental studies of the selected site were initiated in 2014.

The Applicants intend to use a combination of existing and newly collected environmental survey data to support the Project. For the Project footprint north of Livengood, inclusive of the Mainline, GTP, and PTU Gas Transmission Line, a detailed gap analysis was completed of the existing data and gaps were filled during the 2013 summer field season. The Applicants are conducting additional surveys as part of the 2014 summer field season and are planning additional surveys beyond 2014 to survey portions of the Project south of Livengood, as well as specialty studies as required by regulatory agencies. The data collection processes

have been designed to meet the requirements of FERC Resource Reports 1–13, as well as other federal, state, and local permit information requirements.

Public Outreach Meetings

See Response Nos. 4 and 5 above, and Exhibit C, for the status of Project meetings held as of July 31, 2014. Stakeholder engagement meetings were initiated ahead of both the 2013 and 2014 summer field seasons and these meetings will continue in the third and fourth quarters of 2014.

**7. *Proposals from at least three prospective third-party contractors from which Commission staff may make a selection to assist in the preparation of the requisite NEPA document, or a proposal for the submission of an applicant-prepared draft Environmental Assessment, as determined through the initial consultation.***

Under separate cover dated August 8, 2014, the Applicants provided Commission Staff with two (2) short-listed third-party contractor proposals. The Applicants sent the Request for Proposal materials to eight (8) potential contractors and received two (2) qualified proposals. The Applicants request that Commission Staff complete the selection of the third-party contractor as soon as possible to allow the contractor to participate in the upcoming FERC scoping process and open houses.

**8. *Acknowledgement that a complete Environmental Report and complete application are required at the time of filing.***

The Applicants acknowledge that a complete Environmental Report and complete application are required at the time of filing.

**9. *A description of a Public Participation Plan which identifies specific tools and actions to facilitate stakeholder communications and public information, including a project website and a single point of contact. This plan shall also describe how the applicant intends to respond to requests for information from federal and state permitting agencies, including, if applicable, the governor's designated agency for consultation regarding state and local safety considerations with respect to LNG facilities.***

The Applicants are committed to stakeholder communications and effective public outreach. Public participation was initiated in 2013 with public outreach and agency meetings. The Applicants will continue their engagement with federal and state permitting agencies and will conduct follow-up meetings with those agencies to respond to requests for information. As noted previously, the Governor of Alaska has not at this time designated an agency for consultation regarding state and local safety consideration with respect to LNG facilities.

Attached as Exhibit D is a Public Participation Plan that identifies the specific tools and actions to be used to facilitate stakeholder communications and dissemination of public information. The Public Participation Plan includes the following components:

- Ongoing engagement with federal, state, and local officials and community leaders to inform them about the Project;
- Establishment of a Project toll-free number, e-mail address, and mailing address;

- Maintenance of a publicly available website (accessible at <http://www.ak-lng.com>);
- Participation in periodic public community meetings;
- Development of a stakeholder contact and public/agency correspondence log;
- Posting of information in local newspapers and at local libraries; and
- Establishment of a single point of contact for stakeholder communications and public information. 



### **Public Participation Plan**

The Applicants have created a comprehensive Stakeholder Engagement Plan (“Plan”) that is based on providing proactive, transparent, educational, and culturally mindful communications in a timely manner to potentially affected and interested stakeholders, enabling and encouraging them to participate in the process. The Applicants’ expectations for engaging with stakeholders throughout the life of the Project include:

- Proactively consulting and exchanging information with stakeholders;
- Developing long-term, positive relationships through respectful and culturally appropriate dialog with stakeholders;
- Using consultation results to inform decisions regarding project design, impact assessment, timing of construction to avoid impacting subsistence fishing and hunting seasons as practicable, and mitigation, among others;
- Implementing Alaska Content programs (seasonal and permanent workforce and supplier development and community investments) by providing timely information and collaborating with communities and Alaska Native tribal and civil, local, and regional leadership; and
- Implementing systematic processes for responding to issues and information needs, addressing grievances, and providing timely response to stakeholders.

The elements of the Plan include establishing a single point of contact; hosting community meetings for stakeholders; meeting with community leaders, agencies, and elected officials throughout the Project area; communicating with affected landowners and others through email, telephone, direct mail, and in person; producing informational materials for distribution to all stakeholders; establishing a Project website; and preparing for ongoing stakeholder engagement. Where appropriate and requested, materials will be made available in multiple languages and/or a translator will be present at community meetings.

#### ***Single Point of Contact***

The Project has established a single point of contact for public stakeholders affected by and/or interested in the Project. The contact is Michael Nelson and he can be reached at 855-550-5445. The Project will also provide contact information for the FERC project manager and other federal, state, and, local agency project managers.

#### ***Stakeholders***

The Project has developed a database of affected and/or interested stakeholders which includes the following:

- Alaska Native stakeholders including tribal governments and regional and village corporations;
- Boroughs, municipalities, cities, and communities (communities with and without civil government);
- U.S. federal government, including agencies;
- State of Alaska government, including agencies;
- Non-government organizations (NGOs);
- Landowners; and
- General public.

### ***Community Meetings***

The Applicants plan to host community meetings in communities along the proposed pipeline route and near project facilities during the third and fourth quarters of 2014. The community meetings will be offered in the following communities (others will be added as requested): Anaktuvuk Pass, Barrow, Kaktovik, Nuiqsut, Alatna and Allakaket, Evansville and Bettles, Wiseman, Rampart, Stevens Village, Anderson, Healy, Nenana, Fairbanks and North Pole, Minto, Trapper Creek, Talkeetna, Tyonek and Beluga, Cantwell, Eklutna, McKinley Park, Wasilla and Houston, Willow and Nancy Lake, Anchorage, Kenai, Soldotna and Sterling, and Nikiski. The Applicants will coordinate with community leadership to plan community meetings to ensure high attendance and meaningful dialogue between stakeholders and Project representatives (e.g., avoid overlap with important cultural and community events).

An invitation letter with a fact sheet and project map will be mailed in most instances to landowners located within the study corridor of the preferred pipeline route, as well as to community leaders, agencies, and other potentially interested stakeholders. Advertisements for the Project community meetings will also be published in local newspapers and posted in communities.

### ***Cultural Awareness Training***

Cultural awareness training will be provided to all Project representatives who interact with Alaska Natives and who travel to rural communities. Training will be provided by Alaska Natives and focus on the specific cultures, traditions, protocols and people along the proposed pipeline route and near Project facilities. Project representatives who may receive this training include, but are not limited to surveyors, inspectors, project managers, field support staff, engineers, scientists, land agents, etc.

### ***Leadership Engagement***

Project representatives have been communicating with leadership stakeholders by email, telephone, letters, and in person during meetings to provide Project information and document

feedback. Project representatives continue to be available to present Project information to community leaders, public officials, and agencies. At each of the communities listed above tribal entities and Alaska Native Corporation leadership are offered an opportunity to engage with the Project representatives.

### ***Information Materials***

Fact sheets/FAQs, maps, display materials for the community meetings, and other informational materials have been or are being developed for interested stakeholders. Project information will be distributed, as appropriate, at the community meetings and upon request.
