Pursuant to Natural Gas Act § 19(b), 15 U.S.C. §717r(b), and Fed. R. App. P. 15(a), Sierra Club hereby petitions the Court for review of:

1. the Department of Energy, Office of Fossil Energy Order No. 3331-A entered on May 7, 2015 and titled "Final Opinion and Order Granting Long-Term, Multi-Contract Authorization to Export Liquefied Natural Gas by Vessel from the Cove Point LNG Terminal in Calvert County, Maryland, to Non-Free Trade Agreement Nations"; and

2. the Respondent's denial of Petitioner's Request for Rehearing of the order above, found at Order No. 3331-B entered on April 18, 2016 and titled "Opinion and Order Denying Request for Rehearing of Order Granting Long-Term, Multi-Contract Authorization to Export Liquefied Natural Gas by Vessel from the Cove Point LNG Terminal in Calvert County, Maryland, to Non-Free Trade Agreement Nations."
